# PARENT & PLAYER REGISTRATION AGREEMENT

**Respect for Officiating:** Much like our players and our coaches, there will be times when an Umpire makes a mistake/bad call. That is baseball on every level. Players or parents making comments, gestures, or grumblings about bad officiating is never allowed.

**Playing Time:** In our academy and competitive sports in general, playing time is not given but earned. Playing time can be earned in many ways - effort, attitude, performance, and training/practice attendance.

**Questions/Concerns with Coaching:** Some of our coaching decisions may not be the most popular decision, or a decision you agree with. We 100% believe an open line of communication is incredibly healthy for a team. Coaches welcome all questions or concerns from parents if the below rules are followed:

- o The coaches should never be approached/contacted by a parent regarding concerns and/or disagreements with coaching/coaching decisions on a "gameday" unless it relates to the health and safety of an athlete.
- o If you feel that the health and safety of your player or others is being jeopardized, or you feel like the team or its coaches are doing something illegal, please immediately reach out to the academy.

**Refund Policy:** By signing below, you agree that your player is registering and paying for the item / service of "Facility Access" at 1501 NW Broadway St Grain Valley, MO 64029 from 1/1/25 to 7/31/25. By signing below, you agree that this registration is final as you have been given the door code that is active and cannot be changed for this entire period.
